OPERATOR'S PETITION FOR COURT REVIEW OF RMV LICENSE SUSPENSION FOR CHEMICAL TEST REFUSAL

This petition for review may be filed in the appropriate District Court division only after the operator has appeared at the RMV for a license suspension hearing and the RMV has issued a decision. It must be filed within 30 days after issuance of the Registrar's final determination (G L c.90,§24[1][9]), along with a filing fee of \$195 (G.L. c.262,§\$ 2, 4C) unless waived for indigency (G.L. c 261,§5 27A-29). The statute requires that the Court's review be limited to the record established at the hearing before the registrar (§24[1][9]) and therefore the operator may not introduce additional evidence before the Court.
